FIRST. The name of said corporation shall be Taylor Logistics, Inc.

SECOND. The place in Ohio where its principal office is to be located is \_\_\_\_\_

THIRD. The purposes for which it is formed are:

- (a) To engage in any lawful act or activity authorized by Section 1701.01 to 1701.98, inclusive of the Ohio Revised Code.
- (b) Further, by way of example, to do any and all things permitted to an Ohio Corporation, in Ohio and elsewhere; by virtue, of Ohio Revised Statute 1701.13, either in its present form, or if it be re-enacted to enlarge the powers of corporation in such broader form or forms.
- (c) Without limitation on the generality of the foregoing authorization by reason of this specification, the corporation may borrow money without limitation on the amount or terms thereof and, in respect to any such indebtedness, may issue such instruments evidencing such borrowing and enter into such commitments and contracts in respect thereof as may be approved from time to time by the Board of Directors of the Corporation.
